- Movement of Support vehicles to and from service/repair organisations
- Pressure washing
- Comply with 3rd party Client procedures
- Complete Client records / paperwork as advised.
- Carry out Operator Mentoring duties as required

Depot Assistant

- Liaise with HET operators reporting for tasking
- Management and control of CES
- Control and management of the overalls – ensuring overalls are cleaned/replaced by contractor
- Manage the safe control of temporary waste locations
- Transportation of spare parts & equipment as required
- Advise Task Execution Manager/Workshop & Engineering Manager on any issues
- Regular internal mail\stores runs between the Depot and Wing House
- Report and manage faults in Buildings 20 & 23 through liaison with both QM 19 Sqn RLC and Aspire

Management Information Systems

- Manage and maintain documentation and records to comply with COP's in a timely manner

General Duties

- Carry out Vehicle Safety checks in accordance with COP's
- Undertake any reasonable task required of you

Position: Sponsored Reserve (SR)

Location: SR Duties Worldwide. Affiliated to 19 Tank Transporter Squadron.

Reports to: Military chain of command.

Description: Undertake military duties on training, exercises and operations.
